## WHAT INFORMATION DO WE COLLECT?

We collect your name, e-mail address, and all additional information you provide when requesting that we post your information to the Registry, Resources or Calendar.

## HOW AND WHY DO WE COLLECT THIS INFORMATION?

We collect information when you contact us, sign the HAES Pledge, or request to post information to the Registry or Resources.

When you sign the HAES Pledge and provide your email address, we use this information to add your name to the Pledge and to contact you about the Pledge.

When you request to post information to the Registry, Resources or Calendar, we post the information you provide for public viewing on the website.

When you contact us, we may use the email address to respond to questions and/or comments. We may also collect information that will help us better provide you with services.

## WEBSITE ANALYTICS

To improve your experience on our site, we use “cookies.”

Our website uses Google Analytics, a service which transmits website traffic data to Google servers in the United States. Google Analytics does not identify individual users or associate your IP address with any other data held by Google. We use reports provided by Google Analytics to help us understand website traffic. We use the secure protocol https. Data that is transmitted between the user browser and the server is encrypted.
